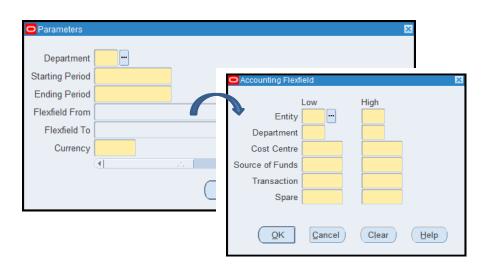


# Account Analysis – Transaction Detail with Categories – Excel Version (UFS)

This report is currently used by selected departments who are involved in the Financial Information Delivery Framework project for Owner and Category Information added to Cost Centres. The aim is from May 2017 to start rolling the function and this report to remaining departments.

This version of an Account Analysis report details individual transactions either on a specific or range of code combinations and will include 'category' information. The report will output directly into Excel (recommend that you *Save As* to a relevant drive) and will contain two worksheets: report information and transactions.
